1. OVERVIEW

- 1.1 This policy reflects the Single Equality Act 2010 which harmonises and replaces previous legislation including the Race Relations Act 1976, Disability Discrimination Act 1995, Gender Recognition Act 2004 and Sex Discrimination Act 1975. This policy therefore supersedes all previous school policies on Disability, Ethnicity (i.e. Race) and Gender.
- 1.2 The Single Equality Act combines the existing three duties into one new Equality Duty that covers all seven of the equality strands: age, disability, gender, gender- identity, race, religion or belief and sexual orientation. In this school we will ensure that at every level, in all our work and throughout all aspects of the school community and its life, everyone will be treated with equity. This Single Equality Policy summarises the school's approach in ensuring equity for all.

2. OBJECTIVES

- 21 To ensure that all learners have equal access to a rich, broad, balanced and relevant curriculum.
- 22 To advance equality of opportunity by ensuring that teaching, learning and the curriculum promote equality, celebrate diversity and promote community cohesion by fostering good relations.
- 23 To eliminate any discrimination, harassment and victimisation. To ensure that no-one is unfairly or illegally disadvantaged as a consequence of their age, disability, gender, gender identity, sexual orientation, gender reassignment, marriage and civil partnerships, colour, race, ethnic or national origin or religious beliefs.
- 24 To recognise and celebrate diversity within our community whilst promoting community cohesion.
- 2.5 To ensure that this policy is applied to all we do
- 26 To ensure that pupils and parents are fully involved in the provision made by the school.
 - 27 To ensure that within the school budget, adequate funding is provided to underpin this policy and that intervention, positive and preventative action is funded where necessary.

3. GOOD PRACTICE

- 3.1 We strive to achieve a cohesive community and expect that children respect one another and behave with respect to one another, and that their parents feel fully engaged in the school.
- 32 We aim to enhance a wider sense of community locally, as well as in the context of the UK and the World communities.
- 33 We support the UN Convention on the Rights of the Child, the UN Convention on the Rights of People with Disabilities, and the Human Rights Act 1998. Through our policies and actions, we undertake to ensure that every child and young person is healthy, safe, is able to enjoy and achieve in their learning experience and is able to contribute to the wider community.
- 3.4 We consider it prudent and sensible to maintain the practice of logging racist incidents and reporting them to the local authority. We monitor and log incidents that discriminate against children and young people or adults in our school with protected characteristics, e.g. homophobic bullying. We also monitor and log bullying incidents, particularly those

- 5.7 This policy will play an important part in the educational development of individual pupils.
- 52 It will ensure that all pupils are treated with equity i.e. as favourably as others.
- 53 The school will make all reasonable adjustments to promote equal opportunity and ensure all members of the school community are treated with equity.
- 54 We are committed to meeting the individual needs of each child and will take full account of their age, disability, gender, gender-identity, race, religion or belief and sexual orientation in accordance with the requirements of The Single Equality Act 2010.

6. EQUALITY OBJECTIVE

- $\it \&l$ The Equality Act 2010 requires schools to publish specific and measurable equality objectives. Our equality objectives are based on our analysis of data and other evidence.
- 62 Our equality objectives focus on those areas where we have agreed to take action to improve equality and tackle disadvantages.
- 63 We will regularly review the progress we are making to meet our equality objectives.
